Biography

Chris Giovinazzo represents plaintiffs and defendants in high-stakes disputes across a wide range of industries, including health care, technology, and financial services. He has extensive experience managing complex contract litigation, intellectual property cases, and corporate fiduciary duty/governance disputes. Chris regularly serves as lead trial and appellate counsel in multi-million-dollar matters.

He represents both employees and employers on issues involving executive severance, non-compete and non-disclosure agreements, trade secrets, and discrimination claims, and defends law and accounting firms in professional liability cases.

Chris has a strong background in environmental law, having represented numerous clients in environmental regulatory and litigation matters. He spent three years as a consultant to local governments on environmental, energy, and land-use policies and was the editor-in-chief of the Harvard Environmental Law Review.
